


Perceptions of UK public and 'horse people' re the use of horses in sport

Re gene doping & cloning: The document "PROPOSALS FOR RULES CHANGES OF EQUINE ANTI-DOPING & CONTROLLED MEDICATION 2024" (available here:

https://inside.fei.org/system/files/12-EADCMR_Rules%20Modification_26%20June%202024_0.pdf) says "topic of gene doping is also being discussed within International Horse Sports Confederation as the Racing Authorities may update their wording on the matter. Any relevant updates/changes may be incorpor Final Draft".

This document mentions prohibition of gene doping and mentions cloning but makes no specific statement about their stance on the latter.

I also found this (slide deck):

This prementions cloning but again makes no statement about the FEI's stance on it. But I summarised the evidence surrounding its use in horses for something I did Edinburgh & it wasn't good - hence my text in the notes (although the summary I created was a couple of years ago now - I can look again if you would like know).

Summary

- The threat posed by the public's attitude to horse sport is real – and imminent
- Prioritising welfare is key to preserving our sport and to turning this challenge into an opportunity for growth
- This must be based on:
 - Embedding a 'horse-first', 'horse-centric', ethicsbased mindset
 - Being open to challenge and change
 - Funding and acting on the results of high quality research
